WHEREAS, as part of the Notice Program, Petitioners were ordered to post the initial filings in this proceeding, as well as all papers subsequently filed in this proceeding, to the website www.lbhirmbssettlement.com (the "Lehman A77 Website");

WHEREAS, the Petitioners have complied with the requirements of the Notice Program, including with respect to the Lehman A77 Website (NYSCEF Doc. No. 38); and

WHEREAS, as of the Judgment entered on June 5, 2024 (NYSCEF Doc. No. 318), all of the issues pertaining to the Subject Settlement Trusts have been resolved through various partial judgments and severance orders,

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, subject to the approval of the Court, as follows:

- The purpose of maintaining the Lehman A77 Website as part of the Notice Program has been fulfilled and there is no need to continue to update or maintain the Lehman A77 Website.
- 2. The Petitioners may cause the Lehman A77 Website to be shut down and its contents deleted following the entry of this Stipulation and Proposed Order.
- 3. This stipulation may be executed in counterparts.
