No. 239) (the "Referral Order"), the Court ruled its resolution of certain disputed issues required interpretation of agreements over which the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court") had retained jurisdiction, and ordered Petitioners to "advise the Bankruptcy Court of this decision and order" and further ordered the proceeding "stayed pending hearing and determination by the Bankruptcy Court of the aforesaid issues";

WHEREAS, in a series of partial severance orders and partial final judgments entered between December 17, 2018 (NYSCEF Doc. No. 196) and June 5, 2024 (NYSCEF Doc.
